He also represents developers and owners to obtain the ancillary approvals that are required from the Suffolk County Department of Health Services ("SCDHS"), Suffolk County Sewer Agency and Pine Barrens Commission, including the transfer of Pine Barrens Credits and other sanitary credits, when necessary.
