Her leadership in economic and public health initiatives includes securing public and private support for a National Heritage Corridor, collaborating with 234 municipalities and 23 counties to promote economic development, cultural preservation, and community health improvements across Upstate New York.

During her tenure with the New York State Attorney General's Office, she played a key role in consumer protection and healthcare system reform, investigating systemic issues and facilitating dispute resolution between insurers, healthcare providers, and patients. Additionally, she has been a strong advocate for Federally Qualified Health Centers (FQHCs) and led the creation of a Leadership Development Initiative in Community Health, pioneering workforce development in rural not-for-profit healthcare organizations.
