absent external forces. I think these changes are here to stay, and I suspect firms will be more willing to embrace technological experimentation going forward."

Cole sits on the Office of Court
Administration's (OCA's) CPLR advisory
committee. In 2019, she was elected as a
Fellow by the New York Bar Association. In
2013, Cole was installed as the first female
president of the Federal Bar Association's
Eastern District of New York Chapter, in
which she remains active.

Cole earned a juris doctor, magna cum laude, from St. John's University School of Law and a bachelor's degree from Colgate University.
