"In the area of commercial leasing, tenants will not only look for reduced rentals and other concessions should this economic downturn continue; but tenants will also look to negotiate or restructure other lease terms that become more significant in a weakening economy. These terms include broader rights of assignment and subletting, go-dark provisions, rights of termination and provisions for reduction of tenant's premises."

Counsel for landlords and tenants will have to work together to address the needs of their clients in this changing market to creatively develop restructured terms that work for all parties to the lease, Sandler noted.

Prior to joining Farrell Fritz in 1991, Sandler was a real estate associate at a New Jersey law firm. He also worked in the Northeast regional real estate department of The Southland Corporation, where he was responsible for site selection, development and leasing activities.
