Former New York State Governor Mario Cuomo to Speak at Huntington Hilton Hotel

On Friday evening, September 10, 2004, former New York Governor, Mario M. Cuomo, will speak at a program sponsored by the Suffolk County Bar Association and the Suffolk Academy of Law, and chaired by Ilene S. Cooper, Esq., a partner with Farrell Fritz, P.C. and a Bar Association officer.

Mario Cuomo was elected New York State's 52nd governor in 1982 and won re-election in both 1986 and 1990. He is currently a partner at Willkie Farr & Gallagher LLP, where he practices national and international corporate law.
